Cameron Oil & Gas Co., Inc. is proposing to change the proposed access road on the APD submitted for the above captioned well. The original road was coming from the east through NM State land. Due to right of way costs, it was determined that the state road access to the east was more costly when added to the BLM required ROW in Sec. 23.. The new proposed access road will start on the Katrina County Rd south of the location of the Amoco Fed. #1 well and will be entirely on lease as an old oilfield road to the Amoco #1. Section 26 is Fee Surface of the Bogle Ranch and an agreement has been made to compensate them for surface damages. The existing access road will be upgraded by clearing the vegetation growth and blading the road for a total of approximately 9,900 feet. The proposed 1500' of access road between the Amoco #1 & #2 will also be cleared. Archaeological Survey Consultants, P.O. Box 2285, Roswell, NM 88202 will conduct an archaeological survey of the road and will submit their report to the appropriate government agencies.
