Drill out rubber plug & cmt frm 12,408' to float collar @ 12,630'. Tst csg to 4000 psi - ok. Circ hole w/2% KCL wtr. TOOH w/bit & collars. RU W/L, run 4 650" gauge ring to PBTD @ 12,639'. Run CBL TIH w/tcp assembly & pkr to 12,580'. Set pkr @ 12,461'. ND BOP & NU tree. Drop vent tube & open vent below pkr, tst csg to 2000 psi - ok. Rig up flw back line & manifold. Perforate wr-morrow @ -12,557' - -12,570' - (2SPE) 26 holes. Rig down pulling unit, turn well over to production.
