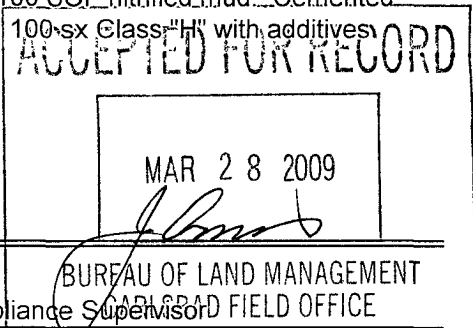

Circulated 128 sx to pit. Cemented stage 2 with 370 sx LiteCrete with additives (yld 2.34, wt 9.9). Tailed in with 100 sx Class "H" with additives (yld 1.18, wt 15.6). Circulated 30 sx to pit. NOTE: Assisted with 100 SCF nitrified mud. Cemented stage 3 with 450 sx LiteCrete with additives (yld 2.34, wt 9.9). Tailed in with 100 sx Class "H" with additives (yld 1.18, wt 15.6). Circulated 24 sx to pit.
