5. Squeeze 35 sx @ 1315-1215' & tag.
6. Perforate @ 488'.
7. Squeeze 40 sx @ 488-388' & tag.
8. Spot 10 sx at surface. Cut off wellhead, anchors & cover pit.
9. Install dry hole marker.


