**DRILLING DESIGN:** Closed Loop System – CLS (Closed Loop Specialties) supplied roll-off steel bins (pits).

**COMPLETION DESIGN:** Closed Loop System – Flow tank during completion  
A ~200 bbl flow tank will be provided by CLS.

**CLOSURE:**

During drilling and completion operations, all solids, cuttings, and associated liquids were hauled off by CLS to the Gandy Marley Landfarm Permit #19. The closed loop equipment was inspected daily by the rig crew during drilling and completion operations. There were no leaks or spills during drilling or completion operations. The entire closed-loop system for both drilling and completion operations was on the wellpad.
