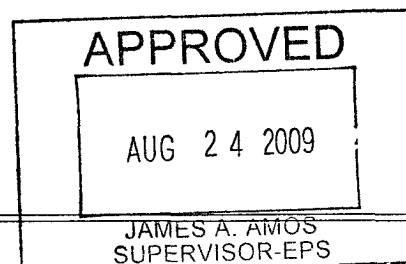

The current P & A procedure expires on August 21, 2009. BOPCO, L.P. is in the process of recompleting BEU #133 and may need additional time to P & A, if recompletable is unsuccessful. BOPCO, L.P. will have the wellbore returned to usefulness or P & A'd within 90 days if an extension is granted.
