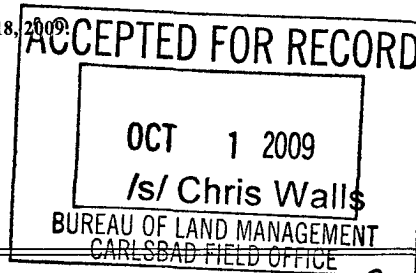

September 10, 2009 - Perforate 888-894, 878-884, 842-862 @ 4 spf. Set retrievable bridge plug at 911'. Break down perforations (888-894, 878-884) at 1040 psig, pump 1000 gals of 7 1/2% NEFE acid at 3.75 bpm. ISIP 850 psig, 5 min SIP @ 587 psig. Pull bridge plug to 868', set packer at 747'. Break down at 1540 psig, pump 2000 gallons 7 1/2% NEFE at 3.7 bpm @ 1144 psig, ending rate 3.7 bpm @ 1025 psig, ISIP 820 psig, 15 min SIP 531 psig. Flow Well. Reset RBP @ 911' and packer at 813'.

September 11, 2009 - Swab well. SDFN.

September 15, 2009 - Run pump, rods and tubing and place well on production September 18, 2009.
