Mixed @ 14.8/g w/1.34 yd. Plug down @ 11:00 am 10/29/09. Circ 40 sks to pit. WOC 18 hrs. At 3:30 am 10/30/09 tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 7 7/8" bit.

11/03/09 TD'd 7 7/8" hole @ 3253'. Ran 3253' 4 1/2" 11.6# J55 LT&C csg. Cemented w/100 sks Thixad Class H with additives. Mixed @ 14.6 /g w/1.52 yd. Followed w/300 sks BJ Lite Class C (50:50:10) w/additives. Mixed @ 11.5#/g w/2.71 yd. Tail with 350 sks Class C with additives. Mixed @ 14.8/g w/1.33 yd. Plug down @ 3:30 pm 11/03/09. Did not circ cement. Slow rate lift pressure @ 700# @ 3 BPM. Displaced w/2% KCl water. At 3:30 pm 11/03/09, tested csg to 1500# for 30 mins, held OK. Set wellhead slips w/30k.
