Breakdown perfs w/ about 3500 gal 15% NEFE acid & frac w/about 65,000# 16/30 & 25,000# 12/20 sand in 25# X-linked gel. CO after frac & retrieve RBP @ 2770'. CO to PBTD3449'. Run tbg & land @ about 3352'. Run pump, & rods & initiate producing load water.
