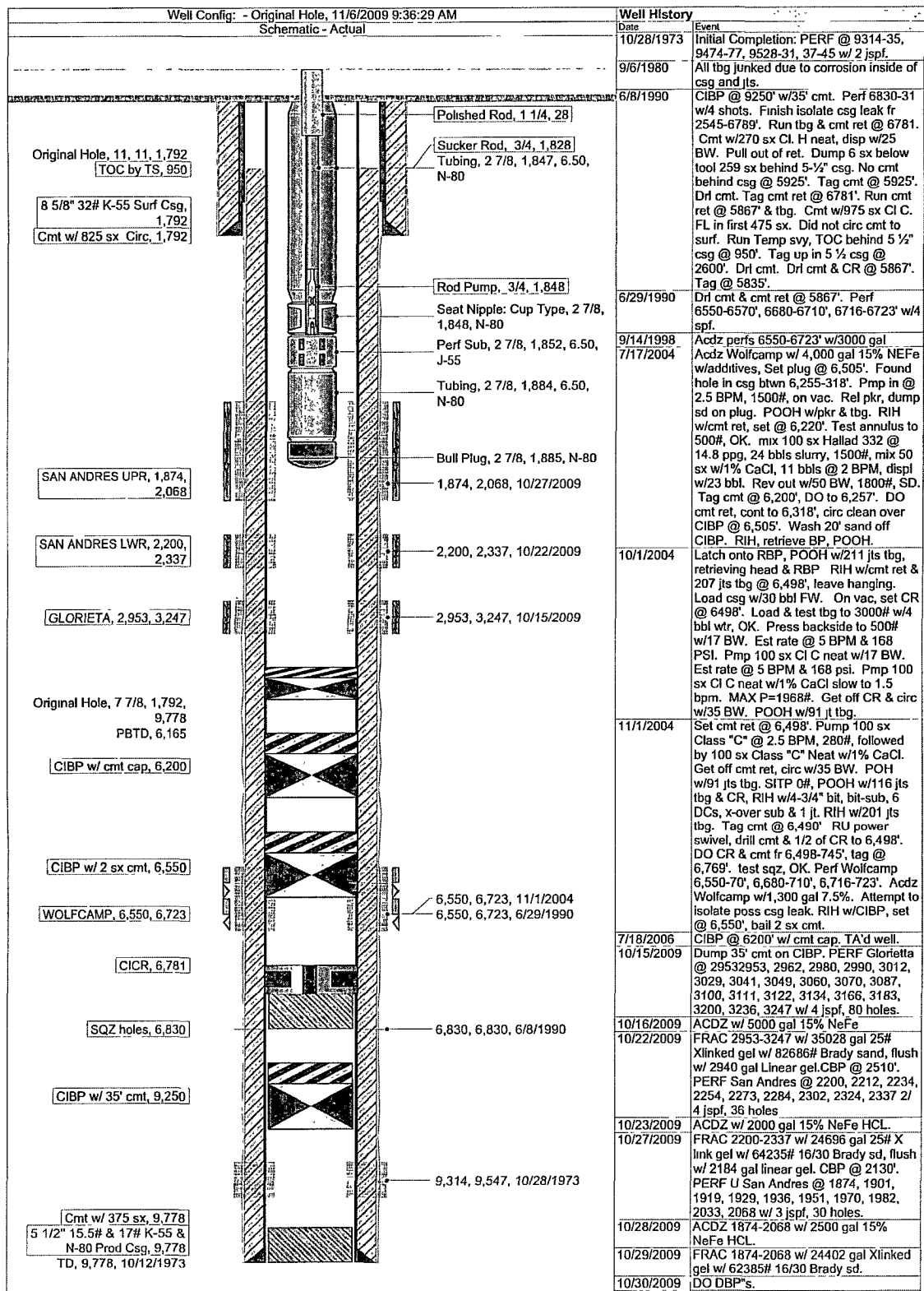
Current Wellbore Schematic
