Our proposed plan is to install approximately 3358.7 feet of one 4" above ground, low pressure flowline from the Fed 23 #9 to the Fed 23#1 tank battery. We also plan to run approximately 206.9 feet of over head electric line from an existing electric line to the Fed 23 #9. The project is located in Sec 23, T-22-S, R-31-E, Eddy County, New Mexico. All construction is on lease and will begin within 30 days of BLM approval. Survey plat attached for your review.

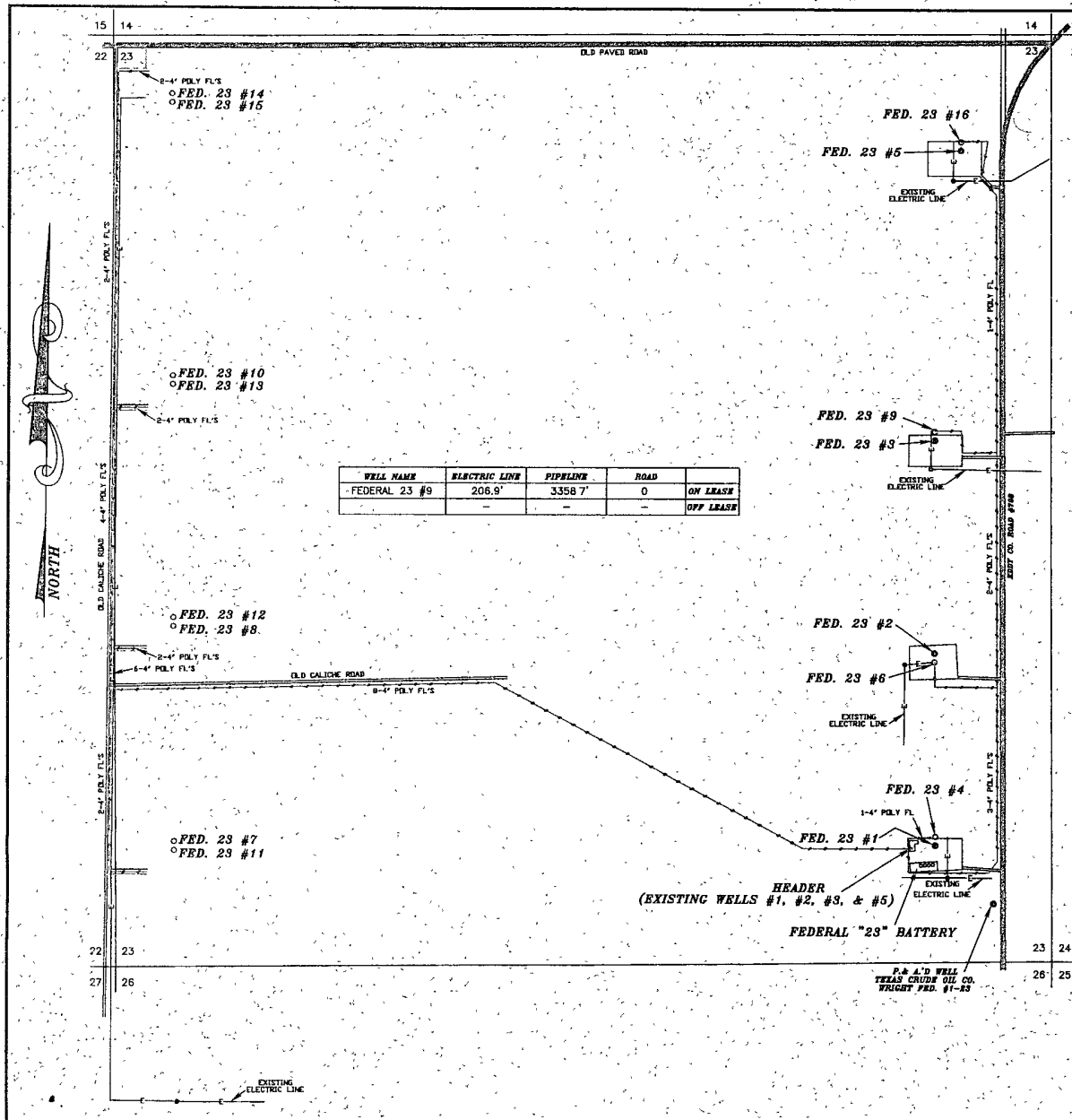

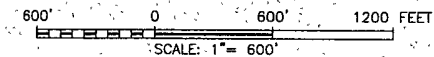
