Lime Rock Resources A. L. P. proposes to drill/test the Empire formation. Approximately 350 feet will be drilled with fresh water, then set and cement 8 5/8" surface casing to 350 feet.
Drill 7 7/8" hole to T.D. at approx. 5,500'. Run O/H logs. Set 5 1/2" casing to T.D. and cement will be circulated back to surface.
Will perforate the Empire formation and stimulate, as necessary, for optimum production. Produce well by flowing or pumping.
H2S levels are not expected to be high enough to require an H2S contingency program.

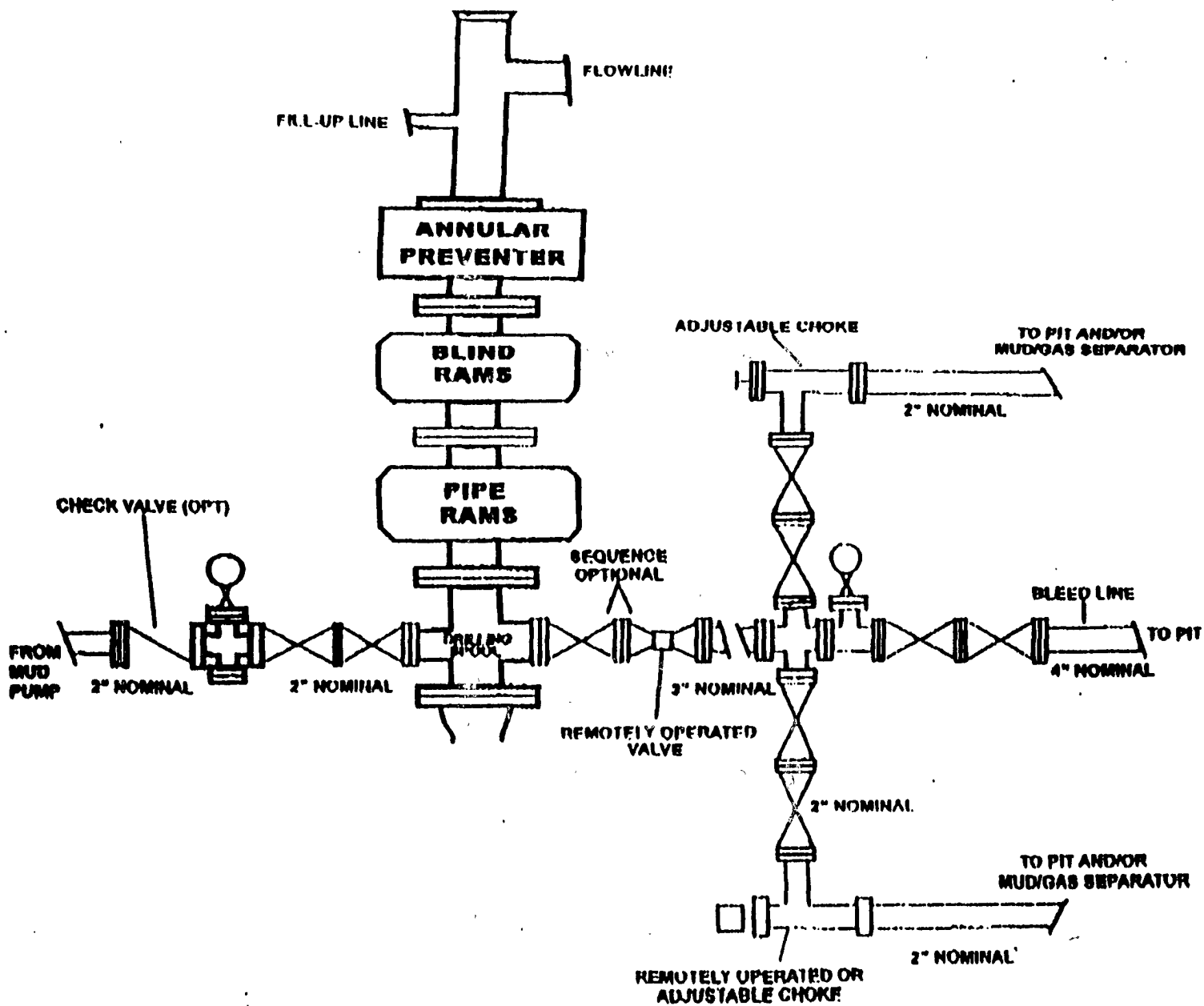
