13 Describe Proposed or Completed Operation. Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomplete horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. 3/20/10 Resumed drilling at 4:30 AM. TD 17-1/2" hole to 270'. Set 13-3/8" 48# H-40 ST&C casing at 270'. Cemented with 290 sx Class "C" + 1% S001 (yld 1.33, wt 14.8). Cement circulated to surface. Jerry Blakely with BLM did witness. Tested casing to 1200 psi for 30 min. Start 1215 psi, end 1197 psi. WOC 24 hrs. Reduced hole to 12-1/4" and resumed drilling.

3/23/10 TD 12-1/4" hole at 11:30 AM to 2659'. Set 9-5/8" 36# J-55 ST&C casing at 2659'. Cemented with 1000 sx 35.65:6 Poz "C" + 2#/sx D042 + 0.125#/sx D130 + 27.65#/sx D132 + 5.325#/sx D20 + 61.1#/sx D903 + 0.177#/sx D46 + 4.787#/sx D44 (yld 2.07, wt 12.6). Tailed in with 200 sx Class "C" + 94#/sx D903 + 0.094#/sx D13 (yld 1.33, wt 14.8). Cement circulated to surface. Terry Cartwright with BLM was on location to witness cement job. Terry Cartwright was notified that cement fell back. Ran temperature survey and found TOC at 400'. Ran 1" cement to surface with 440 sx Class "C" cement. Terry Cartwright was notified of operations but was not on location to witness 1" cementing. WOC 45 hrs. Reduced hole to 8-3/4" and resumed drilling.

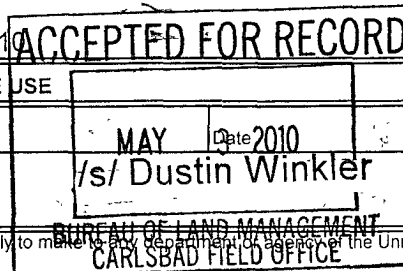
