Yates Petroleum Corporation plans to plug and abandon this well as follows:

1. MIRU. Rig up any safety equipment as needed. NU BOP.
2. Set a CIBP at 2280' with 35' cement on top.
3. Spot a 25 sx Class "C" cement plug with 2% CaCl across intermediate casing shoe from 610'-970'. WOC 2 hrs. Tag plug, reset if necessary.
4. Spot a 30 sx cement plug across surface casing shoe from 0'-434'. WOC. Tag plug, reset if necessary.
5. Cut off wellhead and install dry hole marker and clean location as per regulated.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits

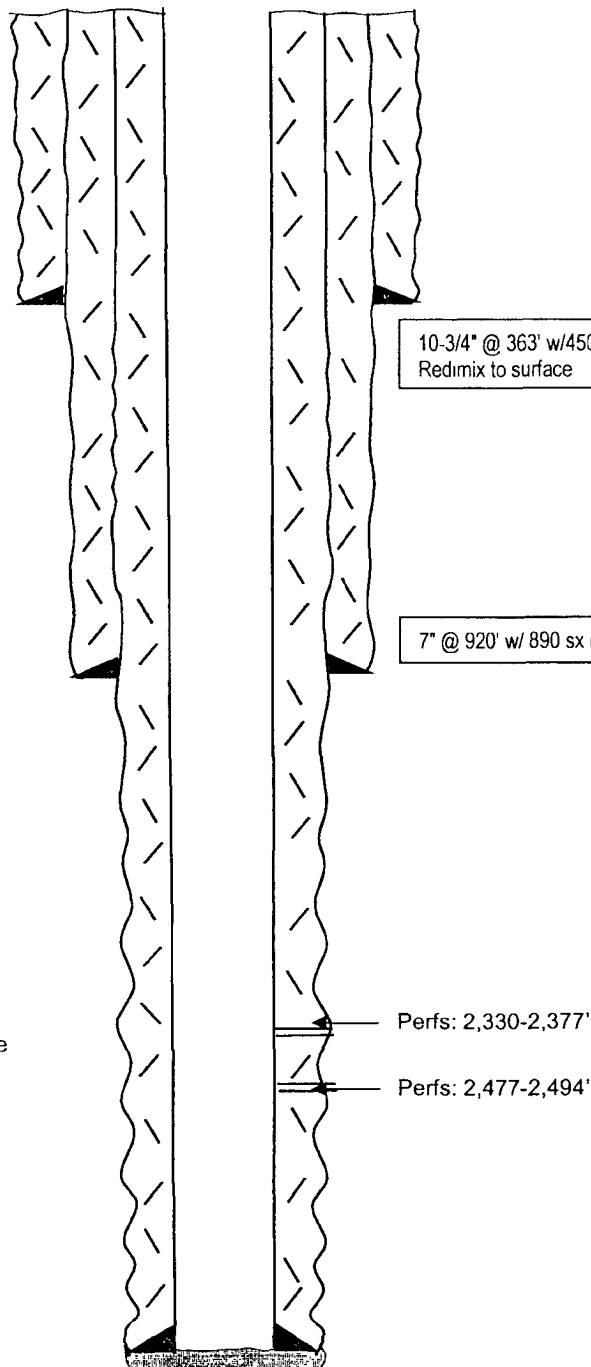

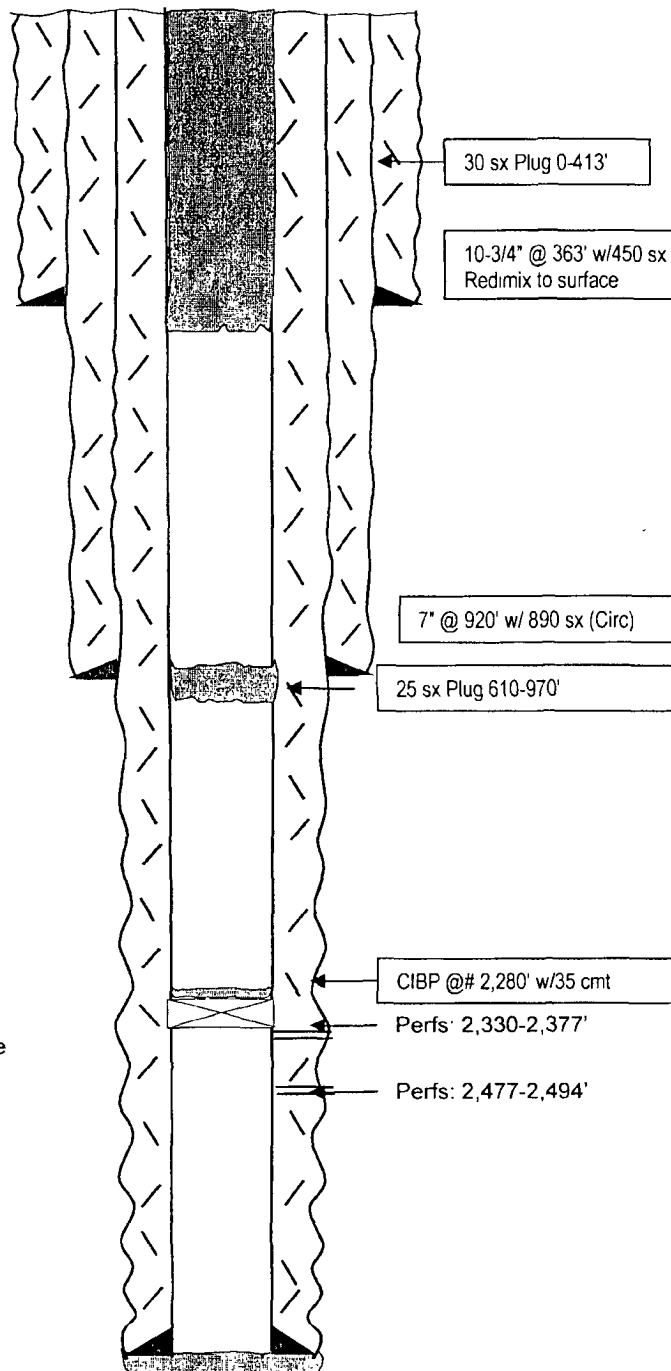
