5/12/2010 RIH w/93 jts, tag CIBP @ 2955', circulate salt gel and spot 25 sks "C" neat. Pull up to 1413' and spot 50 sks C w/2% CaCl. POH and WOC. RIH and tagged cement @ 899', pull up to 421' and pumped 50 sks C neat, circulated cement to surface. Install Dry Hole Marker.
