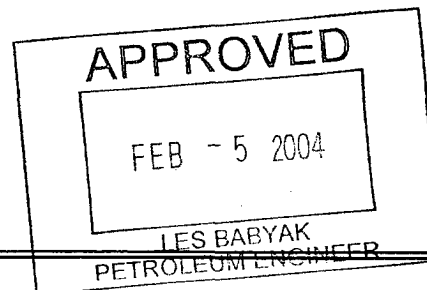

**Procedure to Plug and Abandon**

- Set CIBP @ 2100' and dump bail 35' of cement on top.
- Spot 20 sx cement plug from 800' to 900'.
- Isolate leak in 4 1/2" casing.
- Cement squeeze hole in 4 1/2" casing per BLM. (Call Alexis Swoboda @ 505-627-0272 for procedure.)  
Tag cement plug.
- Spot 20 sx cement plug from 310' to 410' and tag.
- Spot 20 sx cement plug from 50' to surface.

Note: Fill hole w/ 9.5 ppg mud laden fluid
