OPERATING AND MAINTENANCE PLAN

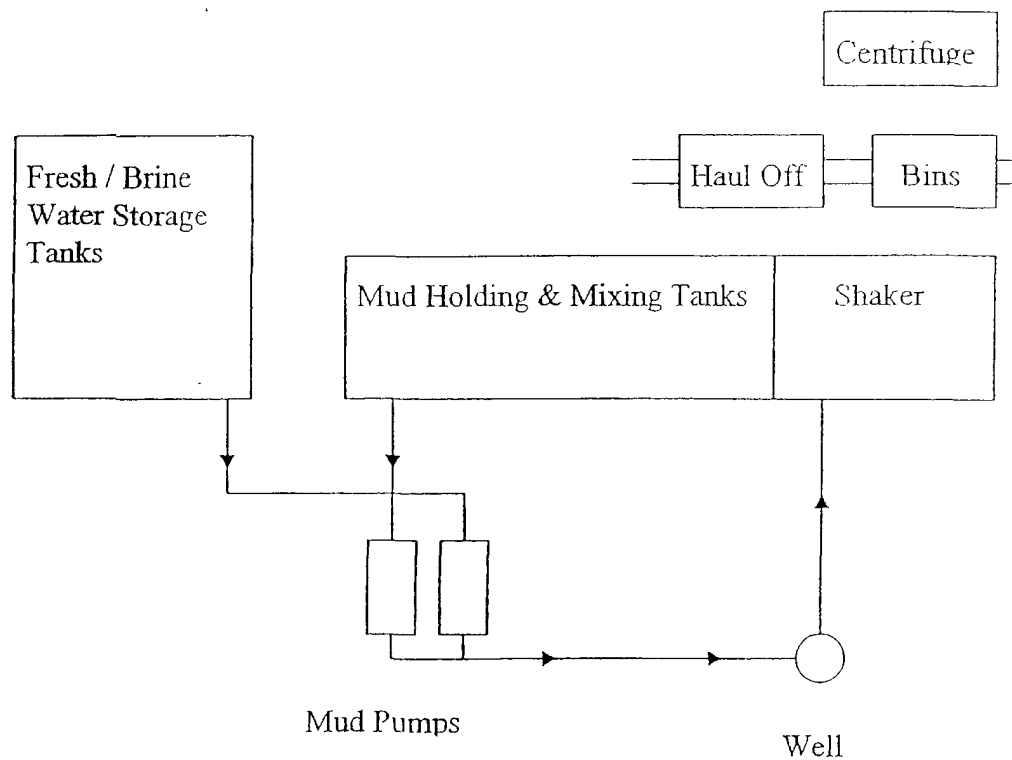
