1. MIRU PU. POH laying down rods. NU BOP. Test BOP System. POH with tbg & pkr @ 11,026.
2. RU EL Unit set CIBP @ 11,066 set 35' cement on top of CIBP. Circulate well with fluid and pressure test to 500#.
3. Notify OCD and set up to run MIT and TA well.
