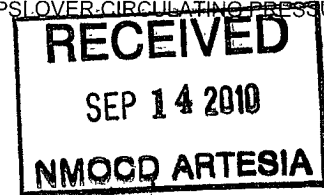

Cemented: 1000 SKS CLASS "C" CEMENT WITH 4% D-20, 1% S-1, 2% D46, .125 #/SK D130, YIELD 1.96 CU/FT PER SK = 1960 CU/FT = 349.1 BBLS OF 12.9 #/GAL LEAD CEMENT FOLLOWED WITH 200 SKS CLASS "C" CEMENT WITH 2% D13, YIELD 1.34 CU/FT PER SK = 268 CU/FT = 47.7 BBLS OF 14.7 #/GAL TAIL CEMENT DISPLACED WITH 209 BBLS FRESHWATER. BUMPED THE PLUG WITH 500 PSLOVER CIRCULATING PRESSURE. FLOAT HELD. HAD 60 BBLS OF GOOD CEMENT BACK TO SURFACE.

Drill out cement 26 hours after in place.
