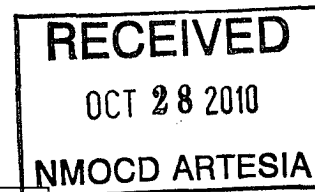

10/5/10 – Circulated hole with salt gel. Spotted a 30 sx Class "H" Neat cement plug from 7579'-7394'. Did not tag. Spotted 30 sx Class "C" Neat cement at 6558'. Est TOC at 6373'. Did not tag. Spotted a 35 sx Class "C" Neat cement plug from 6026'-5811'. Did not tag. Spotted 35 sx Class "C" Neat cement at 3878'. Est TOC at 3663'. Did not tag. Spotted a 35 sx Class "C" Neat cement plug from 2301'-2086'. Did not tag. Spotted a 35 sx Class "C" Neat cement plug from 1229'-1014'. WOC. Tagged at 1001'. Pumped 25 sx Class "C" Neat cement at 157'. Circulated to surface. ND BOP. Topped out casing with cement.
