

 10/29/10 – Set a 7" CIBP at 7600'. Loaded and tested casing to 500 psi. Circulated salt gel. Spotted 30 sx Class "H" Neat cement on top of CIBP. Calc TOC at 7415'. Spotted 35 sx Class "C" Neat cement at 5720'. Calc TOC at 5505'. Spotted 35 sx Class "C" Neat cement at 3598'.
 11/1/10 – Spotted 35 sx Class "C" Neat cement at 2319'. Calc TOC at 2104'. Spotted 35 sx Class "C" Neat cement at 1175'. WOC. Tagged at 968'. Spotted 25 sx Class "C" Neat cement from 158' up to surface. ND BOP. Topped out casing.
 11/6/10 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar and cut anchors. **WELL IS PLUGGED AND ABANDONED.**
