Spud well on 10/2/10. Drilled 12-1/4" hole to 450'. Landed 8-5/8" 24# J-55 csg @ 433'. Cmted lead w/100 sx (163 cf) "C" cmt w/ 1% Cacl2, 10# calseal, 10# gilsonite, & 1/8#/sx p-e-flake & 175 sx (236 cf) "C" cmt w/2% Cacl2 & 1/8# P-e flake. Tailed w/200 sx (264 cf) "C" cmt w/2% Cacl2. Circ 197 sx cmt to surface. On 10/4/10, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3543' on 10/11/10. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 3627'. Cmted lead w/375 sx (709 cf) 35/65 poz C cmt w/0.125#/sx p-e-flake, 3#/sx salt, & 3#/sx gilsonite. Tailed w/400 sx (532 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4#/sx D-air. Circ 129 sx cmt to pit. Released drilling rig on 10/12/10. Plan to pressure test the 5-1/2" csg before completion operations.

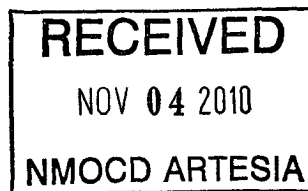
