11/21-12/4/03 RU and laid down joints of tubing. Rack 118 joints - 2-7/8". Tally in. Tagged at 2889'. Opened well and picked up 4-1/16" overshot and 2-3/8" grapple in 3-1/2" jars, bumper sub and 4-3-1/2" drill collars, 85 joints 2-7/8". Tagged at 2887'. Tried to fish and couldn't. Circulated well and started milling at 2887'. Milled out 2'. Closed BOP and circulated bottoms up. Opened well and broke circulation. Fished jar on fish came loose. Opened well and tagged at 3582'. Drilled out to 3664'. Opened well, break circulation. Start drilling at 3664'-3670'. Circulated bottoms up. POOH with 107 - 2-7/8" joints and 6 - 3-1/2" drill collars and 4-3/4" drill bit. RIH with 6 - 3-1/2" drill collars and 102 - 2-7/8" joints above perms. Closed BOP and shut down. Opened well and run 6 joints in. RU swivel and start to mill at 3670'-3729'. Circulated bottoms clean. Pulled 7 joints out. Closed BOP and shut down. RIH with 3 joints and tag on casing walls. Run up and down at 3670' and run tubing to 3728'. Laid down 107 joints 2-7/8" tubing and 6 - 3-1/2" drill collars and shoe on bottom. Nipped down BOP. Rigged down.

Well put back on production for 1 month to evaluate.
