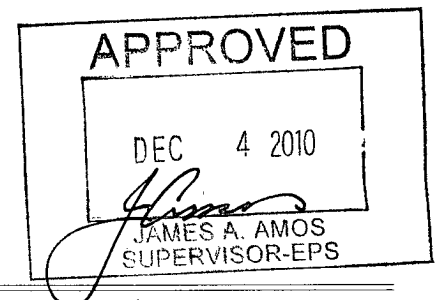
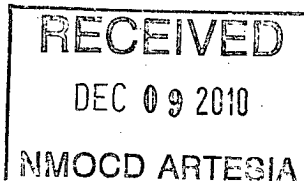

1. Pull tubing & pkr. Set CIBP @ ±9600' w/2 sx cmt on top
2. Perforate Strawn Lime 8585-8600' 1 SPF w/ CG (16 holes)
3. Run 2 3/8" N-80 tbg & pkr to ±8540'. Acidize perfs 8585-8600' w/1500 gals 20% HCl w/25 BS @ 4-6 BPM.
4. Swab & flow back to test
5. If needed re-acidize w/±7500 gals 20% at 6-8 BPM w/25 BS
6. Flow test and put on production
