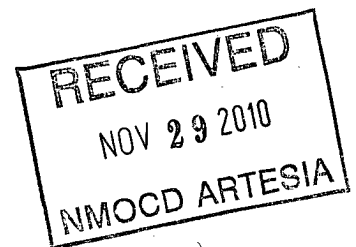

Chesapeake, respectfully, request, permission to do injectivity testing from 5095 ? 5150 in the Cherry Canyon while waiting on frac crews. We will set a packer at approximately 5,000' and run a MIT on injection tubing by 5 1/2" casing annulus which will be witnessed by Paul Swartz with the BLM.

We also plan to change the injection tubing from 2 3/8" to 2 7/8" IPC.
