11/16/10 Tested casing to 500 psi. Circulated hole with salt gel. Spotted 30 sx Class "H" Neat cement at 7588'. Calc TOC at 7403'. Spotted 80 sx Class "C" Neat cement at 6080'. Calc TOC at 5587'. WOC. Tagged at 5585'. Spotted 35 sx Class "C" Neat cement at 3737'. Calc TOC at 3522'. Spotted 35 sx Class "C" Neat cement at 2280'. Calc TOC at 2065'. Spotted 35 sx Class "C" Neat cement at 1178'. Calc TOC at 963'.

11/17/10 Tagged plug at 954'. Spotted 25 sx Class "C" Neat cement from 150' up to surface. ND BOP. Topped out casing.

11/20/10 Dug out cellar and cut off wellhead. Mixed 35 sx cement and topped off annulus. Installed dry hole marker. Filled cellar and cut off anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
