

PDU 511 had perfs added in the Delaware A and B sands. Removed production equipment. RIH w/ bit clean down to CIBP @ 4180'. Acidize existing perfs 4080-4146' (30 holes) w/ 1700 gals petrol-10. Set RBP @ 4050'. Spot 1000 gals NEFE HCL. Perf Delaware A and B 3940-3950' (10 holes), 3973-3983' (10 holes), and 4000-4004' (4 holes). Broke down new perfs w/ spot acid. Frac new perfs w/ 27,575 gals 25# XL gel 44,480 # of 20/40 SLC sand. Remove RBP. Clean down to PBTD (4180'). Ran after frac GR. No treatment in 3940-3950' or 4000-4004'. Set RBP @ 3965'. Acidize 3940-3950' perfs w/1000 gals 15% HCL. Remove RBP. RIH w/ 127 jts. 2 3/8" tbg. TAC @ 3917. RIH w/ production equipment. Place well back on production.
