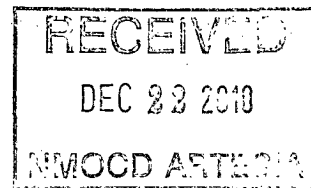

PDU 307Y had perfs added in the Delaware A and B sands. Removed production equipment. RIH w/ bit clean down to PBTD (4558'). Acidized existing perfs 4134-4422' (45 holes) w/ 2000 gals 15% NEFE HCL and 200 gals Xylene. Set RBP @ 4090'. Spot 500 gals 15% NEFE HCL. Perf Delaware A and B 3952-3956' (5 holes), 3967-3977' (11 holes), 3993-4002' (10 holes), and 4033-4038' (6 holes). Broke down new perfs with spot acid. Frac new perfs w/26,332 gals 25# XL gel and 38,435# 20/40 SLC sand. Remove RBP. Clean down to PBTD (4558'). RIH w/ 132 jts. Of 2 3/8" J55 tbg. TAC @ 3,888'. RIH w/ production equipment. Place well on production.
