Mixed @ 14.8 /g w/1.34 yd. Plug down @ 5:30 am 11/09/10. Circ 70 sks cmt to pit. Tested BOPE to 2000# & annular to 1500#. At 1:30 am 11/10/10 tested casing to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.

11/17/10 TD'ed 7 7/8" hole @ 5186' MD. Ran 4 1/2" 11.6# P110 & 5 1/2" 17# J55 BT&C csg w/Packers Port-system. End of casing @ 5176' MD. Ran 10 ports w/10 pkrs.

11/19/10..Released rig at 3:00 pm.

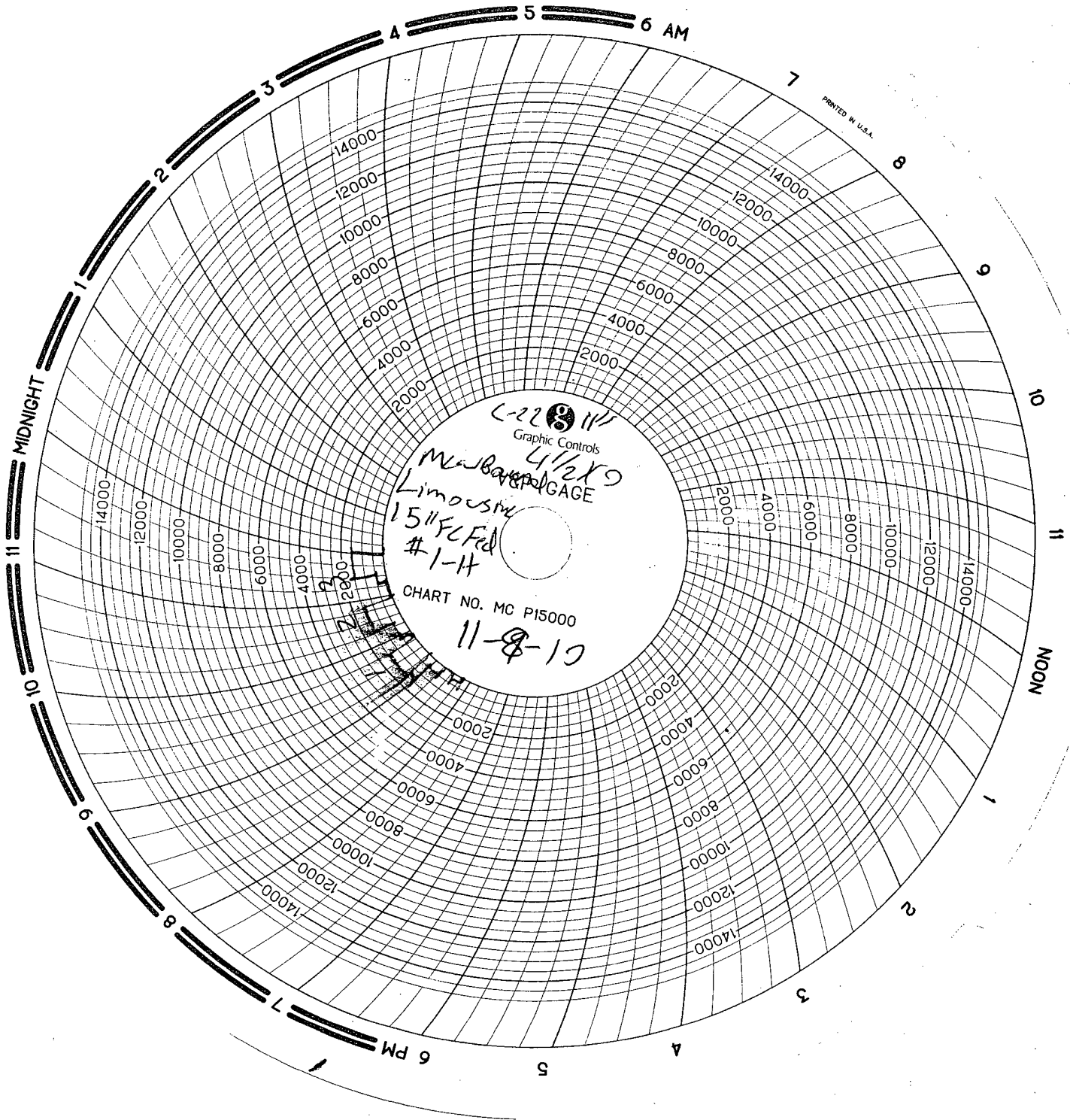

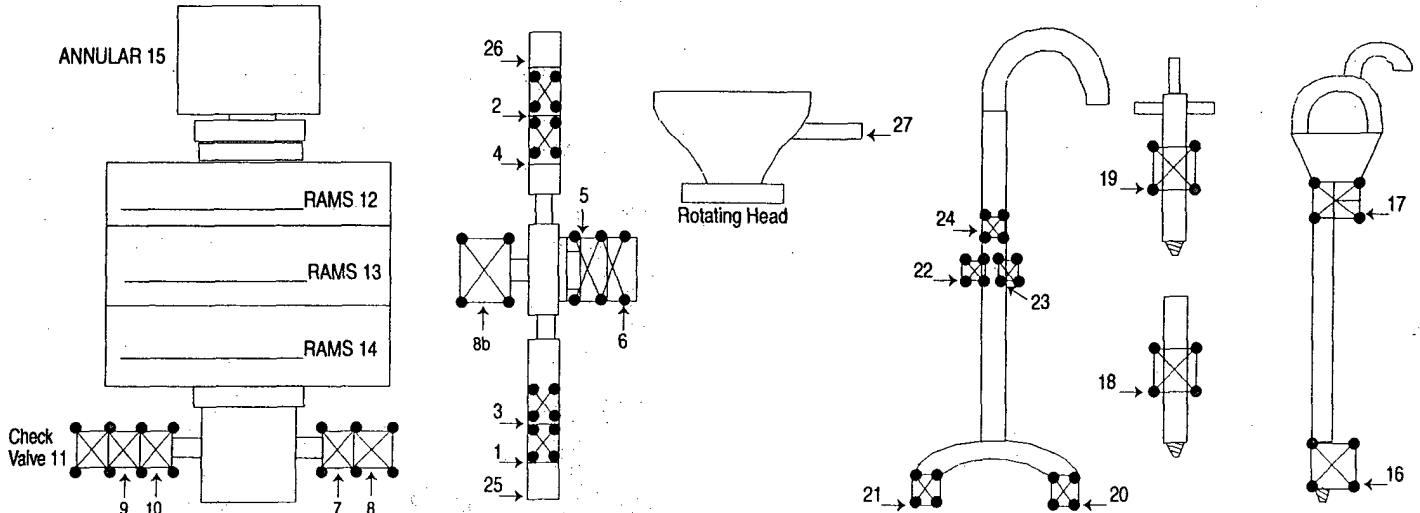
