05/21/10 Lay down rods. Pull tbg & laydown BHA. RIH w/tbg & tag fill @ 2285'. Spotted 70 sks "C" Neat (14.8#/g w/1.34 yd) plug from 2280' to 1066'. POOH w/tbg. Set 4 1/2" CIBP @ 1025'. Pumped 85 sks Class "C" Neat (14.8#/g w/1.34 yd). Circ 10 sks to surface. POOH w/tbg Unscrew wellhead & top off w/5 sks Class "C" Neat (14.8#/g w/1.34 yd).

05/29/10 Cut off Larkin Head. Tagged cmt in 4 1/2" x 8 5/8" annulus @ 558'. Installed dryhole marker.

06/10/10 RIH w/1" to 425'. Cmt 4 1/2" x 8 5/8" annulus w/83 sks Class "C" Neat (14.8#/g w/1.34 yd). Circ 3 sks to surface. Pickup caliche & recontour location. Will reseed this spring.
