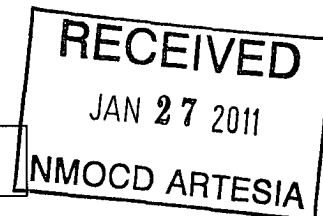
Nearburg Producing Company respectfully requests an extension to the current TA status for the subject well. The TA status for the well is approved until 2-13-11.
