Drill 7-7/8" hole to 8145'V. Log well, RIH w/ 5-1/2" 17# J55 LTC csg @ 8144' w/ DVT @ 55937', POST @ 4002'. Cmt 1st stage w/ 480sx Super H, circ 120sx cmt to surf. Cmt 2nd stage w/ 630sx Super H, circ 174sx cmt to surf. Cmt 3rd stage w/ 380sx HES Light PPC followed by 150sx PPC all w/ additives, circ 104sx cmt to surf. Rel Rig 1/11/11.
