Describe Cause of Problem and Remedial Action Taken.\*

Scale plugged the 2" polyline causing the line to rupture. The release occurred on location 10' north of the pumping unit. A section of the poly was removed from service the line was repaired and then placed back into service.

Describe Area Affected and Cleanup Action Taken.

The impacted area was located on location due north of the wellhead. The soil in the area is loamy soil over laying Caliches. The weather at the time of the release was dry and clear. The impacted area was measured to be 25'x15'. The visibly impacted soil was excavated and then hauled to an NMOCD approved Solid waste disposal facility. Soil samples will be taken for analytical from the excavated area. The soil samples will be submitted to a second party Lab. The TPH will be analyzed using EPA method 8015M; B-TEX will be analyzed using EPA method 8021B. When analytical results report the TPH and B-TEX to be under the RRAL for the site, the excavation will be concluded and the excavated area back filled back to grade using clean soil. A final C-141 form will then be submitted to the NMOCD requesting closure for the release that occurred on 1/18/2009.
