Spud well on 3/8/11. Drilled 12-1/4" hole to 412'. Landed 8-5/8" 24# J-55 csg @ 396'. Cmted lead #1 w/100 sx (163 cf) Thixotropic "C" cmt w/1% Cacl2, 10# calseal, & 1/8#/sx p-e-flake. Cmted lead #2 w/175 sx (236 cf) "C" cmt w/2% Cacl2 & 1/4# pe flake. Tailed w/200 sx (264 cf) "C" cmt w/2% Cacl2. Did not circ cmt. Found TOC @ 74' & filled annulus w/redi mix cmt to surface. On 3/9/11, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5215' on 3/25/11. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 5199'. Cmted lead w/550 sx (1045 cf) 35/65 poz C cmt w/0.125#/sx p-e-flake, 3#/sx salt, 0.5% Halad-9, & 3#/sx gilsonite. Tailed w/650 sx (865 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4#/sx D-air. Circ 105 sx cmt to pit. Released drilling rig on 3/27/11. Plan to pressure test the 5-1/2" csg before completion operations.
