**Oil measurement.**

Each of the wells will be equipped with continuous metering separators for oil production prior to oil being commingled for sales at the Juniper BIP Federal #5. Total sales/production will be allocated back to each individual well using the metered (daily well tests) volumes. Metered volumes will be compared to total battery volumes daily and monthly for accuracy.

Estimated daily oil production for the Juniper BIP Federal #5 is 3 barrels of oil per day, for the Juniper BIP Federal #6Y is 55 barrels per day, for the Juniper BIP Federal #8H is 59 barrels per day, for the Juniper BIP Federal #9H is 141 barrels per day, for the Juniper Federal #10H is 117 barrels per day, and for the Juniper BIP Federal #11H is estimated 141 barrels per day.

The purpose of the Surface/Pool Commingle of production is in the interest of conservation, economic feasibility, the reduction of environmental impact area, and will not result in reduced royalty or improper measurement of production. Without approval for utilizing existing batteries on adjacent leases, it will become necessary to built separate facilities for each well. This will greatly increase costs and shorten the economic life of the well.
