

Mixed @ 14.8 #/g w/1.34 yd. Plug down @ 12:45 PM 03/21/11. Circ 120 sks to pit. WOC 18 hrs. 03/22/11 tested BOPE & casing to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.
