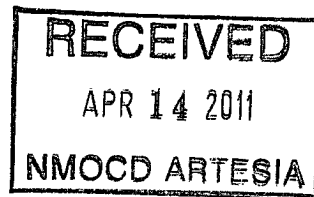

Once the well is horizontal (deviation in wellbore is between ~89-91"inc) bit size will be decreased to 8 1/2" until TD to utilize lateral rotary steerable assembly. ~ 8500' MD
