- Spotted a 25 sack cement plug across perforations 1917-1971 (5 1/2" csg. was cemented at 1986')
- Cut 5 1/2" casing at 1625' and pulled from well.
- Filled hole with mud.
- Spotted a 15 sack cement plug across 5 1/2" casing cut at 1625'.
- Spotted a 15 sack cement plug across 8 5/8" casing shoe at 258'.
- Erected permanent marker in cement in top of 8 5/8" casing.
- Filled pits and cleaned location.
- Plugged and abandoned 7-24-60
