

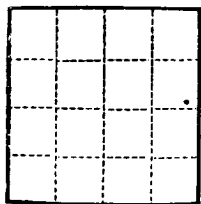

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

10-17-64 Ran 800 ft. of 8 5/8" mud string. Set new 4 1/2" 9.5# electric weld casing to depth of 1041. Total depth of hole 1042. Pulled out of hole the 8 5/8" mud string & then cemented 4 1/2" casing with 135 sacks of cement 2% Jel with 50# tuff plug added for lost circulation material. Pumped in 40 sacks of cement, 2% Jel into 1" macroni string on outside of 10 3/4" surface casing in order to get additional cement in hole above a depth of approximately 148' where cement was shown to be on original temperature survey.
