DETAILS OF WORK

WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Penrose Sand (Queen)

TOTAL DEPTH: 2050'

METHOD OF DRILLING: Cable tools to total depth.

CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. If surface water is encountered in sufficient quantities, will cement 10 3/4" with 50 sacks. If water is encountered in the Red Sand section of Queen formation will run approximately 1850' of 7" OD casing and mud with Aquagel and crude oil. If commercial production is indicated a production string of 5 1/2" OD casing will be run and cemented immediately above the pay horizon.

DRILLING CONTRACTOR: Needham Drilling Company.

DRILLING OPERATIONS TO COMMENCE: On or about August 4, 1959.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

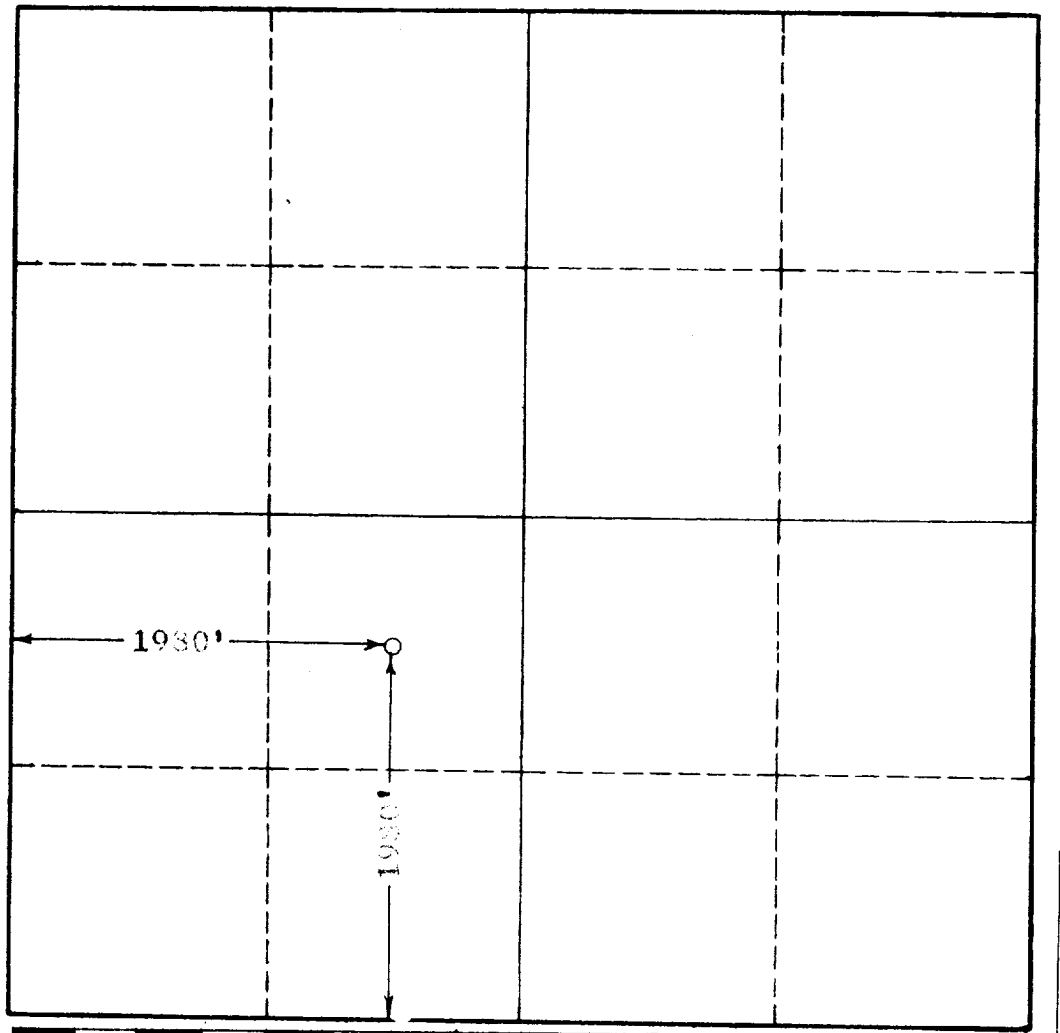
