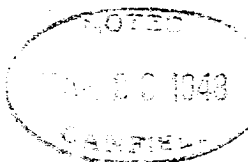
DETAILS OF WORK

Prior to treatment well was flowing 42 barrels of oil thru a 1 1/4" choke.

March 12, 1948: Well was treated conventionally with 1500 gallons of 20% Hydrochloric acid by Dowell, Inc.

After acid well flowed 39 1/4 barrels of oil in 24 hours thru a 3/4" tubing choke.
