This well is pumping 5 BO + 16 BWPD. We propose to stimulate by treating below a packer set in 7" casing with 20,000 gallons My-T gel with 1 1/2 lbs. sand/gal. Protex will be used to inhibit gyp scale. Treatment will be performed in 2 equal stages using 700 lbs. salt and 300 lbs. of benzoic acid for a diverting plug between stages.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
