1-16-61 - Ran 12 joints (366') of 8-5/8" 24#, J-55, Short T&C, J&L Seamless Casing with guide shoe (1.10') to 378.80' with Halliburton Type S-3 Centralizer at 374'. Mixed 140 sax regular cement with 2% Calcium Chloride and pumped plug down to 341' which circulated cement.

1-17-61 - Tested casing to 750# for 30 minutes without pressure drop. Drilled plug and tested again to 750# without pressure drop.
