11/26/97 to 12/2/97 - Ran bit & scraper to 3440'. Ran casing inspection log from 50'-3440'.

12/3/97 to 12/4/97 - Cleaned out fill to 3500'. Acidized perms 3406'-3498' w/2500 gals 15% HCl acid. Swabbed.

12/5/97 to 12/6/97 - Perf'd Grayburg - Lovington 2802'-3307' w/39 - .38" holes. Acidized perms 2802'-3307' w/3350 gals 15% HCl acid + 2500# rock salt. Swabbed.

12/8/97 - RIH w/AD-1 pkr, SN & 2 3/8" IPC tubing. Set pkr @ 2749'. Tested to 360 psi for 15 min, held.

1/6/98 - Returned to injecting.
