Will drill with adequate cable tools to and thru 1895-1950', oil and gas horizon and run 7" O.D. (6 5/8" I.D.) casing- 20 lbs - to top of salt around 500' and cement same with 50 sacks of cement. The cement will be allowed 72 hours to set before drilling is resumed. After the apy has been found, will submit notice of obtain verbal approval for 5 1/2" O.D. casing point, after which 5 1/2" O.D. casing will be set and cemented with at least 100 sacks of cement with heavy mud pumped ahead.
