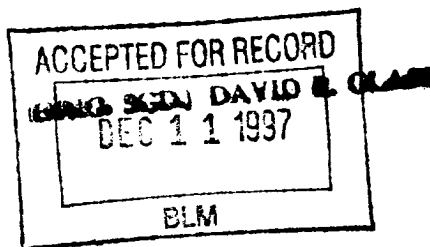

This well was converted to a water injection well as follows:

11/3/97 to 11/8/97 – Cleaned out to 3312'. Perf'd Grayburg 2820'-2992' w/12 holes.

11/10/97 to 11/11/97 – Acidized perfs 2820'-3071' & open hole 3100'-3312' w/5725 gals 15% HCl acid & 4000# rock salt. Ran 4 1/2" AD-1 pkr & 87 jts of 2 3/8" IPC tbg to 2749'. Tested to 380# for 15 min.

12/3/97 – Began injecting.
