Devon Proposes To Permanently Plug and Abandon As Follows:

1. Set CIBP at 2,850' and cap with 35" cement.
2. Set CIBP at 1,730' and cap with 35' cement.
3. Spot cement plug 1,200'-1,300' (base of salt at 1,240'). Tag plug to verify cement top.
4. Spot cement plug 450'-550' (surface casing shoe at 494').
5. Shoot four holes in 7" production casing at 50'. Set cement plug from surface to 50' and attempt to circulate cement to surface outside of the 8 5/8" casing annulus.
6. Set Dry Hole marker and restore location.
