1. On 3/3/76 rigged up & pld rods & pump. Installed BOP. Pulled tbg & MA.
2. Ran 2-3/8" OD EUE tbg OE to 1830' & spotted 30 sx Cl H cmt plug (208') 1665-1873' in btm of 5 1/2" csg. Tagged top of cmt plug @ 1665'.
3. Circ hole w/heavy gelled mud. POH w/tbg.
4. Stretched csg, free pt indicated @ 829'. Cut 5 1/2" OD csg @ 700' & pulled & recovered.
5. WIH w/tbg & spotted 35 sx Cl H cmt across 5 1/2" OD csg stub @ 700'. Tagged cmt plug @ 650'
6. Spotted 40 sx Cl H cmt across 7" OD csg shoe & top of salt @ 511'. Tagged top of cmt plug @ 450'.
7. Spotted 10 sx Cl H cmt plug @ surf & installed regulation dry hole marker. Cleaned & levelled location per USGS & BLM stipulations. P&A eff 3/8/76. Final Report.
