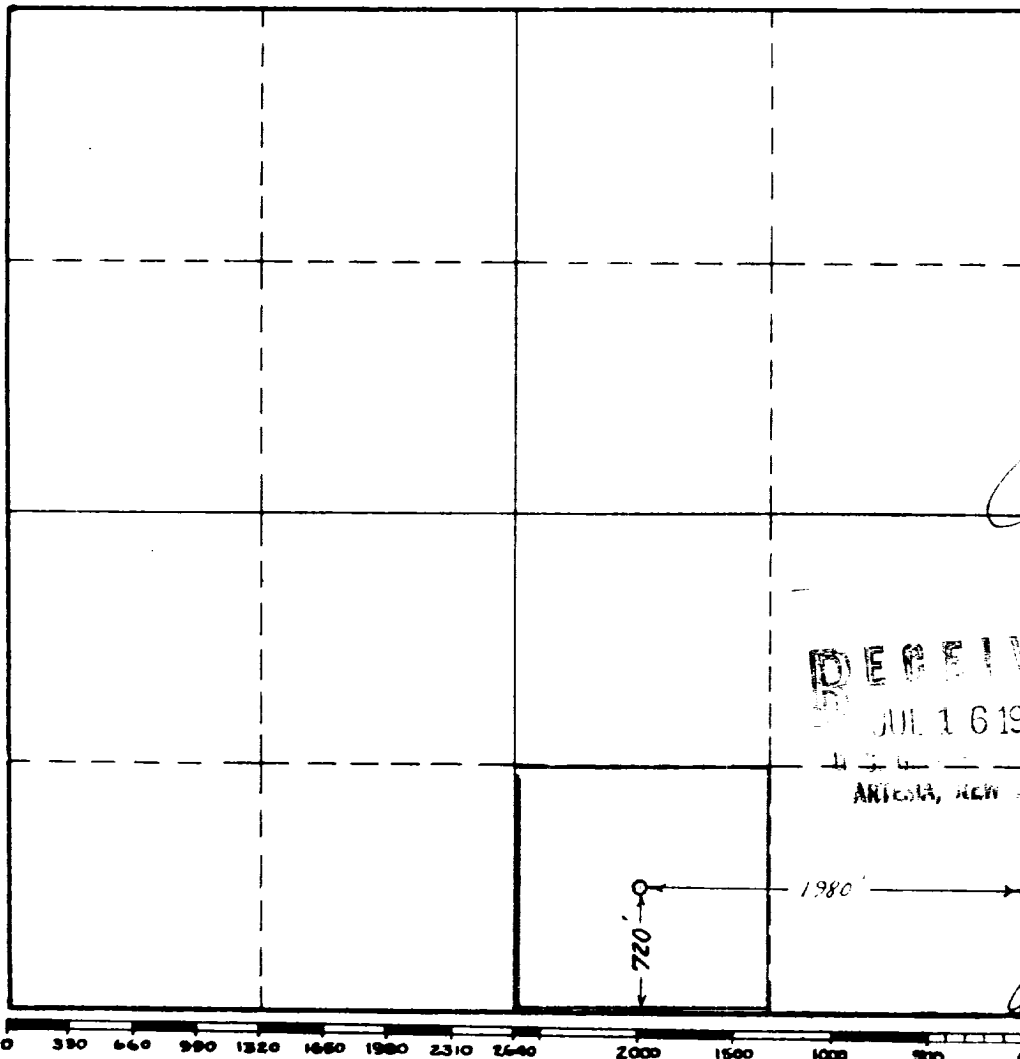

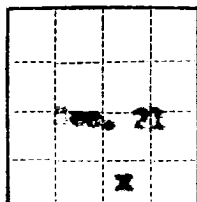

Wellbore process will be used in cementing both strings of casing and cement will be circulated to surface behind the 8-5/8" casing.
