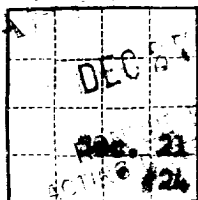

DETAILS OF WORK

1. Move in and rig up workover rig.
2. Pull rods and tubing.
3. Clean well out to total depth and drill well deeper to approximately 3750'.
4. Set 4-1/2" OD casing liner from 3410' to 3750'. (Approximately)
5. Selective perforate the San Andres Zone.
6. Fracture perforations with approximately 20,000 gallons sand-oil
7. Return well to production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
